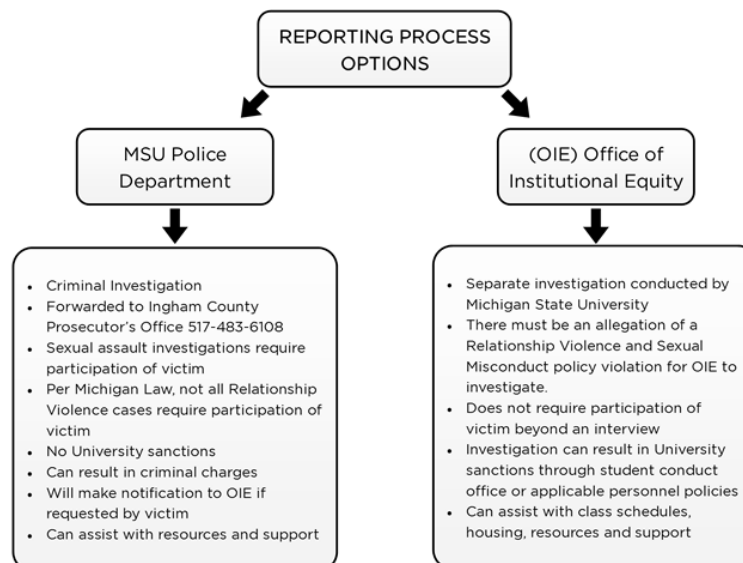
Per our Relationship Violence and Sexual Misconduct Response Commitment:

- We will fully investigate your case. You will be kept up-to-date on the progress of the investigation. Each investigation is forwarded to the prosecutor's office for review, with your input taken into consideration as to the best possible outcome.
- We will continue to be available for you, to answer your questions, and to explain the systems and processes involved (prosecutor's office, court proceedings, university investigation).
- Per Michigan Law, Relationship Violence cases do not always require the participation of the victim

Please be aware that Michigan State University has a policy that prohibits relationship violence and sexual misconduct, including sexual assault. The Office Institutional Equity (OIE) is responsible for enforcement of the university's policy. The OIE process includes:

- An investigation into the allegations of relationship violence or sexual misconduct to determine whether university policy has been violated.
- If there is a finding of a policy violation committed by an MSU student, OIE files a complaint with the Department of Student Life under the student conduct process. This process may end in the respondent's (alleged perpetrator's) suspension or expulsion from the university.
- If OIE files a claim with Student Life, you will have the choice to determine your level of participation, if any.
- The MSU Police Department can contact OIE on your behalf, with your permission.

A PPO is an order issued by Circuit Court that forbids or requires a person (the respondent) to do something. If you want to obtain a PPO, you (the petitioner) have to file a petition with the court.

PPOs can be issued for victims of relationship violence, sexual assault, and stalking.

VICTIMS' RIGHTS

Crime Victims' Rights Act - 18 U.S.C. § 3771

A crime victim has the following rights:

- The right to be reasonably protected from the accused.
- The right to reasonable, accurate, and timely notice of any public court proceeding, or any parole proceeding, involving the crime or of any release or escape of the accused.
- The right not to be excluded from any such public court proceeding, unless the court, after receiving clear and convincing evidence, determines that testimony by the victim would be materially altered if the victim heard other testimony at that proceeding.
- The right to be reasonably heard at any public proceeding in the district court involving release, plea, sentencing, or any parole proceeding.
- The reasonable right to confer with the attorney for the Government in the case.
- The right to full and timely restitution as provided by law.
- The right to proceedings free from unreasonable delay.
- The right to be treated with fairness and with respect for the victim's dignity and privacy.

Crime Victim's Rights Act, MCL 780.751 et. seq

- You may be eligible for crime victim's compensation benefits. To apply, fill out an application available from the Crime Victim Services Commission at 517-373-7373.
- If you would like to be notified of an arrest in your case or the release of the person arrested or both, you call the investigator you are working directly with.
- You can contact the Ingham County Prosecutor's Office at 517-483-6108 to obtain information about victim's rights.

Domestic Violence Notices, MCL 764.15c

1. You may obtain a copy of the police incident report for your case by contacting the law enforcement agency at the phone number previously shown.
2. Your legal rights include the right to go to court and file a petition requesting a personal protection order to protect you or other members of your household from domestic abuse which could include restraining or enjoining the abuser from doing the following:
 - Entering on to premises
 - Assaulting, attacking, beating, molesting, or wounding you
 - Removing minor children from you, except as otherwise authorized by a custody or parenting time order issued by a court of competent jurisdiction
 - Engaging in stalking behavior
 - Purchasing or possessing a firearm
 - Interfering with you at your place of employment or education or engaging in conduct that impairs your employment
 - Engaging in any other specific act or conduct that imposes upon or interferes with your personal liberty or that causes a reasonable apprehension of violence
 - Having access to information in records concerning any minor child you have with the abuser that would inform the abuser about your address or telephone number, the child's address or telephone number, or your employment address

Your legal rights also include the right to go to court and file a motion for an order to show cause and a hearing if the abuser or perpetrator is violating the protection order and has not been arrested.

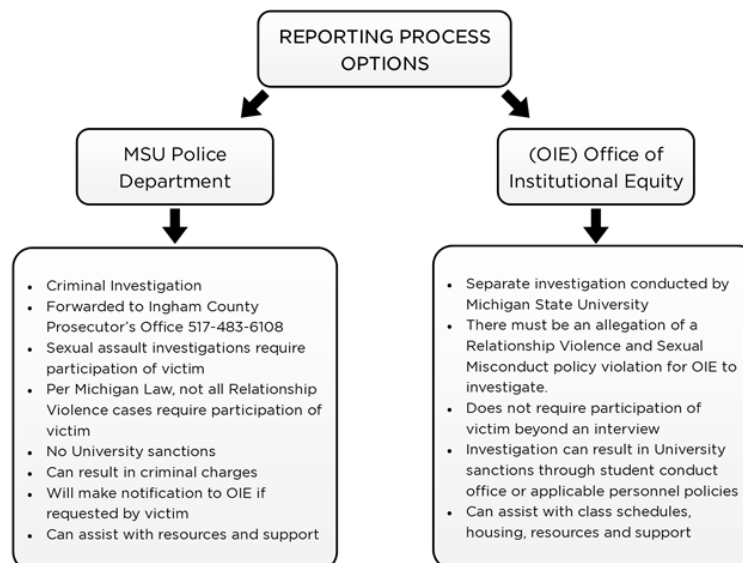

VICTIMS' RIGHTS

Crime Victims' Rights Act - 18 U.S.C. § 3771

A crime victim has the following rights:

Sexual Assault Victims' Access to Justice Act

MCL 752.953

- You can have a sexual assault medical forensic examination and have evidence collected using a sexual assault evidence kit even if you do not want to participate in the criminal justice system or cooperate with law enforcement.
- You cannot be billed for the cost of administering the sexual assault evidence kit. If you receive a bill for these services, contact the Michigan Crime Victim Commission at 517-373-7373.
- You have the right to ask the investigating law enforcement agency for the contact information for the detective or investigating officer assigned to the case, the current status of the case, whether the case has been submitted to the prosecuting attorney for review, and whether the case has been closed and the documented reason for closure.
- If you have had a sexual assault evidence kit collected and released to law enforcement, you have a right to ask the investigating agency for the following information when the sexual assault evidence kit was sent to a forensic laboratory for testing; whether a DNA profile was obtained from the sexual assault evidence kit; whether a DNA profile was entered into CODIS; and whether a DNA profile resulted in a CODIS hit.
- Your legal rights include the right to go to court and file a petition requesting a personal protection order (PPO) to protect you from the perpetrator. The PPO could order the perpetrator not to have contact with you and include other specific conditions.
